

# **Eureka Rookie-Vet Program Leader**

#### **About Us**

Girls Inc. of Alameda County's mission is to inspire all girls to be strong, smart, and bold. Since our founding in 1958, we have programs that support the unique needs of girls aged 5-18, and, starting in the 1990's, to design and deliver programs using an equity lens, serving those from some of County's least resourced communities, primarily in and around Oakland. Through a K-12 Program Continuum, we empower girls by equipping them to navigate gender, economic, and racial barriers and grow into healthy, educated, and independent adults. All programs are developmentally appropriate, supporting girls' changing needs as they grow. From literacy interventions in elementary school and exciting hands-on STEM and STEAM projects in middle school to building leadership skills and college readiness in high school, Girls Inc. girls receive the support and the opportunities they need to thrive. Girls Inc. of Alameda County's operating budget is \$7M with 100 staff in our downtown Oakland Simpson Center for Girls and in more than 15 schools and satellite centers across Alameda County.

#### **About the Role**

The Rookie/Vet Program Leader is a part-time position within the Community Programs Department and on the Eureka team. The Rookie/Vet Program Leader will facilitate engaging STEAM and leadership development programming through hands on activities, field trips, and career exposure to girls in 8th & 9th grade who are enrolled in our 5-year Eureka! Program for the school year. In addition to those duties, the Rookie/Vet program leader will work with peers, supervisor and program manager to support girls' academic progress, coach girls to develop their organization and time management.

The Rookie/Vet program leader facilitates classes 3 days a week at the Girls Inc. downtown location. The candidate for the Rookie/Vet program leader position will be able to make a **commitment to work for the remainder of the current academic school year** with the ability to provide virtual programming as needed and cultivate empowerment in girls while building strong relationships.

### **Job Summary**

- Plan, modify and deliver, in person and/or virtually, STEAM, media literacy and leadership skills development lessons to meet program goals for 3 cohorts of 15-18 girls and gender expansive youth of color that will spark curiosity, creativity, independence, positive risk-taking and confidence in girls
- Create a safe, respectful youth development-based learning environment inperson or virtually.



- Create and review weekly lesson plans with the Eureka Rookie/Vet Program Coordinator prior to delivery.
- Develop creative and engaging projects to deliver in-person or virtually to enhance students' learning.
- Implement lesson plans that are culturally relevant for a diverse population of students.
- Implement lessons aligned with the Common Core State Standards, Youth Development, trauma-informed and culturally relevant practices.
- Organize classroom to facilitate independence, leadership and self-control in students.
- Participate in quarterly evening or weekend events and fieldtrips with participants and their families.
- Supervise youth at STEAM and Leadership related field trips to technology related businesses, community organizations, museums, etc.
- Work closely with Program Coordinators and school staff to track participants' progress.
- Supervise and support adult and teen volunteers.
- Collaborate with community partners to supplement program activities
- Work as a positive team member of Community Programs and participate in mandatory weekly individual supervision, staff development, consultation, training, department and team meetings.
- Maintain organization of program space, communal supplies and paperwork.
- Effectively utilize prep time to prepare for activities and program observations.
- Assist with administrative tasks as needed including recruitment, orientations, materials organization, and lesson plan preparation.
- Perform other duties as assigned.
